RKU Standard, Inc., d/b/a Standard Change Makers ("Manufacturer") warrants the machine provided by Manufacturer (the "Product"), excluding any component(s) not manufactured by Manufacturer ("Third Party Products"), to be free from defects in material and workmanship solely if the customer properly installed, has serviced and operated the Product in the ordinary course of business and in accordance with Manufacturer's instructions and manuals, which are accessible by the quick response barcode on the Product (the "Manuals"). MANUFACTURER MAKES NO EXPRESS WARRANTIES WITH RESPECT TO, AND DISCLAIMS ANY IMPLIED WARRANTIES APPLICABLE TO, ANY THIRD PARTY PRODUCTS INCORPORATED INTO THE PRODUCT, INCLUDING, BUT NOT LIMITED TO, WARRANTIES AGAINST INFRINGEMENT, WARRANTIES OF MERCHANTABILITY AND WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE; provided that manufacturer of Third Party Products may have a warranty for any such Third Party Product and a request may be made in writing to Manufacturer to provide warranty information for such Third Party Products, if any.

No other warranty (express or implied), promise, or affirmation of fact concerning the Product and no other description, sample or model of the Product shall be construed as augmenting, supplementing, or included in any manner whatsoever as part of this limited warranty, and this warranty may not be modified, supplemented, or changed in any way without the written consent of Manufacturer. The warranty period commences on the date the Product is sold by Manufacturer (whether sold to a distributor or directly to a third party) ("Sale Date") and automatically terminates twenty-four months after the Sale Date regardless of whether any owner purchased the Product after the Sale Date from a distributor or party other than Manufacturer.

During the first twelve months after the Sale Date, Manufacturer agrees to repair or replace (without charge to the owner) the Product, or any component thereof (except Third Party Products), if, in the sole discretion of Manufacturer, the Product has defect(s) in materials or workmanship.

During months thirteen to twenty-four after the Sale Date, Manufacturer agrees to repair or replace the Product, or any component or part thereof (except Third Party Products), if, in the sole discretion of Manufacturer, the Product has defects in materials or workmanship; provided that the owner shall pay all labor costs (and Manufacturer will pay for any replacement parts, except for Third Party Products).

### 1.0 QUICK START GUIDE

Your machine has been shipped preprogrammed from the factory. All settings will be programmed to the factory default unless otherwise specified at the time of order. The majority of new machine owners need only read this section in order to learn the basic installation and operating features of your machine. For more detail, or if you just enjoy reading technical information, see the remaining sections of this manual.

#### !!!! CAUTION !!!!

Always disconnect the 24V power supply(s) before adding or removing a module. Failure to do so can result in corrupt data and premature component failure.

### 1.1 Placing The Machine


- The machine should be located in an area where it can be easily bolted to the floor or to a wall for security purposes.
- The door should be able to swing fully open and not come in contact with anything else. This allows easy access for filling the hoppers and removing the deposited money. Some models require a full 180-degree door swing to allow the hopper contents (coins) to be manually dumped.
- If the machine is to be installed in an outdoor location, we recommend a Rear Load model changer. The machine should be located in an area where it will not be directly exposed to the elements: excessive dust/dirt, direct sunlight, and/or direct rainfall. We recommend the use of a canopy over the machine to ensure a longer trouble-free service life as well as to provide a convenience for your customers.
- The machine power cord should be secured in a manner that will prevent accidental or intentional unplugging.

# 1.2 Removing The Internal Shipping Restraints

Internal shipping restraints are typically used to secure the internal machine components during shipping. The restraints used are of various types: shipping tape, shipping brackets or shipping bars. Shipping brackets and bars can be identified by a label with the marking indicating their purpose. These should be removed to allow full access to each device. See examples of shipping restraints below.

### 1.3 Connecting Power To The Machine


The machine can be connected to a standard 115VAC power outlet. We strongly recommend a dedicated line to the breaker panel. If the machine is located in a harsh electrical environment, or if dedicated line is not feasible, the use of a high quality surge suppressor (same as used for home computers) is recommended. If hardwiring of the machine is necessary, a qualified electrician should perform it.

### 1.4 Loading The Coin Dispenser

Loading the coin dispenser is a simple task. For coins contained in a bank bag, grasp the neck of the bank bag and twist it to choke the mouth of the bag. Invert the bag and insert the neck of the bag into the top of the coin dispenser. Loosen your grip on the bag neck slowly, letting coins feed down into the dispenser. The table below shows a convenient filling level for the various standard coin dispensers. When possible, you can turn your bank bags inside out and lessen the chance of small strings and threads from accumulating in your coin dispenser. Clean coffee cans or plastic pails can also be used to fill the coin dispensers.

# 1.5 Loading the Bill Dispenser Cartridge

If your machine is equipped with a bill dispenser read this section carefully. Bill dispenser reliability is directly related to the condition of the bills loaded into the dispenser as well as to the care taken when loading them. Several models and brands of bill dispensers are available. Identify the one included in your machine using the pictures below and become familiar with the bill loading process.

Basic considerations for any bill dispenser are as follows:

BILL CONDITION - Bills that are in average to good condition will dispense more reliably than
heavily worn bills with folds and creases in them. Optimum performance of the bill dispenser is
achieved if the note condition is ATM fit or good teller grade currency. Torn, taped or curled bills


should be culled out. Broken packages (bricks) of new currency mixed with circulation notes will feed but increase the possibility of stoppages. The use of broken packages (bricks) alone or in significant quantities is not recommended. Ensure there are no folds that overlap neighboring notes. For best results, the notes should be loaded into the cassette in 50-100 note batches. Loading the cassette in larger batches can cause the edges of the notes to fold up as they are inserted.

- CORRECT DENOMINATION Ensure that the denomination loaded into the bill cassette is the correct denomination. The dispenser does not have the ability to verify that the bills loaded are the correct denomination assigned to the bill dispenser. Note the value is assigned at the factory and is based on the customer order. To change a *dispenser value*, see the section in this manual called *Machine and Device Features*, sub topic *Dispenser Value*.
- BILL ALIGNMENT It is important that the edges of the notes be reasonably aligned prior to insertion into the cassette. This will reduce the number of jams and bills rejected to the *reject bin*.
- CASSETTE HANDLING Gently press bills into the cassette, do not force them.
- REMOVING REJECTED BILLS Bills that could not be successfully dispensed will be diverted to the *reject tray*. These are not counted in the audit and the customer will still receive the correct amount. These bills should be removed from the bill tray. Do not attempt to reuse them as they will not likely dispense the second time either.
- SOLD OUT GENERAL A small number of bills will remain in the dispenser when it becomes "sold out". This insures that enough bills remain to finish any dispense that is in progress. These bills may be reloaded along with new bills.
- SOLD OUT FUJITSU 40 to 70 bills will remain in the Fujitsu dispensers after it signals a Sold Out condition. An optional filler plate is available that will reduce this number to 10-30. The part number for the filler plate is 4M00774-M. Avoid using this plate if any number of bills to be dispensed during a transaction is greater than 10. Using the plate in this case may not leave enough bills to finish a payout in progress and in turn can prevent the *Transfer Feature* from functioning as desired. Example: Dispensing 20 \$1 bills and 6 \$5 bills for a \$50 deposit. If the filler plate is used the \$1 bills can run out before the vend cycle is completed. If only 12 of the \$1 are present, the user cannot possibly receive the correct change since an odd number of \$1 bills are dispensed; 12 \$1 bills and 7 \$5 bills will be dispensed in this case if the *Transfer Feature* is active. Since only 12 \$1 bills were present at the start of the vend, the user will be short changed \$3. In this case if the filler plate is not used the 20 \$1 bills would have been available.


#### **CAUTION!**

Some cabinet models include a tilting or rotating slide plate to allow easy access for loading bills. Use caution when operating these to avoid pinching your fingers or damaging the cables.

### BILL DISPENSER MODELS AVAILABLE











FUJITSU MODEL F50 DISPENSER LOADING – Rear load machines (door on back of machine) utilize a "slide" and "rotate" plate for optimum access for bill loading. Front load machines do use a slide only. They do not include the rotate plate.



STEP 1 - Slide / pull dispenser out as far as it will go.



STEP 2 - Swivel the dispenser (rear loads only) to allow additional bill compartment access.



STEP 3 – Open the bill compartment door of the dispenser.



STEP 4 – Slide the pressure plate back and snap into position.

**STEP 5** – Load bills so they are standing on end. Release the pressure plate so the bills are pushed forward.

FUJITSU MODEL F53 DISPENSER LOADING – Push the green release button (label) on the cassette to be removed and view instruction decals located inside the dispenser cartridge.



**STEP 1** – Push green release button on front of cassette to remove it from the dispenser.



STEP 2 – Press green button on back of cassette to open it.




STEP 3 – Lift pressure plate in rear as shown.



**STEP 4** – Lift pressure plate in front and load bills.

**STEP 5** – Return pressure plates to original position and install cassette into correct location in the dispenser.

STEP 1 – Use the handle to pull the cassette from the bill dispenser.

**STEP 3** – Return the pressure plate to the original position and install the cassette.



**STEP 2** – Pull the green pressure plate towards you and insert a stack of good conditioned bills.

STEP 1 – Use the handle to pull the cassette from the bill dispenser.



STEP 2 – Insert and rotate the key. Slide the latch to the right while lifting the lid.



**STEP 3** – Pull the green pressure plate towards you and insert a stack of good conditioned bills.

**STEP 4** – Return the pressure plate to the original position, close the lid and install the cassette.

### 1.6 Testing the Machine Operation

TURNING POWER ON / OFF – Your machine is equipped with a power disconnect feature. The type of disconnect used is dependent upon the machine model purchased. Below are pictures of the various each disconnects used. It is always a good idea to unplug the machine from the 110VAC power source whenever possible.

It is always a good idea to position the machine power cord in a location where it cannot easily be tampered with.

STATUS INDICATORS - When installation is complete and an ample supply of coins has been loaded in the dispenser(s), and power has been turned on, the machine is ready for operation. The *Status LED* (yellow / top) on each dispenser should be flashing at a fast steady rate of approximately 5 flashes per second. This flash rate indicates that this dispenser is ready to operate. Be sure to check the *status LED* on every dispenser to ensure the machine is fully functional; the machine can remain in service even if a dispenser is not functional. You are now ready to test the machine for proper operation. Note: A slower flash rate (approx. 1 flash per second) indicates an error condition.

### 1.7 Troubleshooting An Error Condition On The Dispenser

If an error condition is present on any dispenser, the *status LED* will be flashing at a rate of one flash per second and there will be a brief delay (LED will be off for approx. 3 seconds) between consecutive flashes. This flash pattern indicates an error condition. If this occurs, count the number of flashes between the pause. Do this several times to verify the correct *Flash Code* (number of consecutive flashes before the pause). Refer to the "ATTENTION MACHINE OWNER" decal shown below (also found in machine) to determine the source of the error for this flash code. Next, refer to the troubleshooting section of this manual and find the probable causes for the error, as identified in the Troubleshooting Chart. Once the failure cause has been corrected, reset the dispenser using the procedure outlined below. The *status LED* flash rate should now return to the fast (5 flashes per second) steady rate.

#### ATTENTION MACHINE OWNER

FLASH CODES: In the event of a machine OUT OF SERVICE CONDITION please use the FLASH CODE table below to determine the source of the machine error. To determine the flash code, count the number of consecutive flashes from the blinking LED indicator on the device in error. The flash code should always be noted before contacting your distributor or a service center

Example: For flash code #2 (Bill Acceptor Error): LED = ON - OFF - ON - OFF. The flash code will repeat until the error condition is cleared.

### 1.8 Resetting the Dispenser

#### **PUSH BUTTON**

Each dispenser is equipped with a *push* button that can be used to reset the dispenser from an error condition. It is only necessary to reset the coin dispenser that is displaying the error flash code. Allow at least 45 seconds after releasing the button, for the entire reset process to be completed. The flash code should change back to the steady flashing pattern if the error was successfully reset.

# 1.9 Removing Bills From The Bill Acceptor Bill Box

The bill box is attached to the rear of the bill acceptor. Each bill box will have an access door that can be easily opened to allow the accepted bills to be removed. The location of the access door varies depending on the bill acceptor model, yet all are easily viewable. See the pictures below for the common access door locations.

### 1.10 Emptying The Coin Dispenser


The majority of coins in a dispenser can be removed from the hopper using the *bulk dump* method. Bulk dumping refers to the manual method of emptying coins from a dispenser into a container. A few coins will remain in the dispense disk following a *bulk dump*; these coins can be removed by performing an *electronic dump*.

#### **CAUTION**

As a safety precaution you should never place your fingers in or near the coin dispense chute or in the coin storage area of the coin dispenser when power is applied to the dispenser.


### **Bulk Dump Method**

Bulk dumping is performed the same way for all standard capacity (3200 quarters) coin dispensers. Do not use the bulk dump method to empty a high capacity hopper unless it has only 30% or less of the coins remaining. Coin dispensers in front load machines tilt forward, and dispensers in rear load machines tilt back. Always TURN POWER OFF before bulk dumping a hopper for safety purposes. To tilt the coin dispenser, pull forward at the top edge of the dispenser.

**Electronic Dump** - The coin dispenser must first be in a "Sold Out" condition and not in error. This condition occurs when the remaining coins are insufficient to complete a vend for a large denomination bill. The diagnostic LED will be blinking at a slow steady pace indicating a Sold Out condition. To begin, turn the machine power off, then back on. Wait for the machines Out Of Service lamp to change from the constant ON state to a BLINKING or OFF state. Make sure that the dispenser is flashing a dispenser sold out code. If any other flash code is shown when pressing the *Push Button*, it will reset the dispenser. You will have to power cycle the dispenser again. Next, press and release the *Push Button* (see diagram above for location). The dispenser will begin dispensing within 5 seconds. The coin dispenser will stop when all coins have been cleared. Note: The *push button* must be pressed within 5 minutes of the time the power was turned off / on to the machine.

### 1.11 Removing Coins From The Coin Acceptor Box

If your machine was equipped with the optional coin acceptor, you will need to empty the coin acceptor box when it becomes full. To do this you need only to lift the coin box from the retaining bracket, empty the box and then return it to the original position. The coin box should be free to be removed without the use of tools. Some models have a shipping bolt or nut that is used to attach the coin box to the mount during shipping. If this has not been removed, remove it at this time. The shipping bolt or nut is no longer required.

NOTE: ON THE MC700 CHANGER, REMOVE THE 2 SCREWS IN THE BOTTOM OF THE CHANGE BOX TO ALLOW THE BOX TO BE REMOVED TO DUMP THE COINS.

The MC machine series is equipped with a highly efficient "switching power supply". One advantage of this type of power supply is its ability to deliver steady output power when encountering large fluctuations in input voltage - 100VAC to 135VAC. In addition, this supply will only use power when it is needed during the change making process. This means the heat created by the power supply is only generated for brief periods of time and as a result will create very little heat build-up inside the machine. Heat build-up can have adverse effects on the life of the machine components as well as the performance of the bill acceptor.

The power consumption of your particular machine model will vary depending on the number of modules in the model you have purchased. One hopper machines will require a maximum of 60 Watts of momentary power, two hopper machines will require **80 Watts**, and Dual machines models that include a second supply may require up to 160 Watts momentarily.

Ancillary items can increase the overall machine power consumption requirement. An example would be the power consumption of a heater kit. The power consumption of this device (device draws 100% load when on) is equal to the wattage of the heating element. A 100 Watt heating element in addition to the momentary power supply draw of 80W would bring the total maximum power consumption of the machine to 180 Watts. The maximum wattage for the entire machine, including ancillary items, should not be allowed to exceed **360 Watts**.

#### 1.13 Environmental Considerations

Advance consideration should be given to the environmental conditions (temperature, dirt and moisture extremes) the machine will be exposed to. A *base machine* model is intended for use in locations where moderate temperatures are encountered and the machine has minimal exposure to the elements. A typical location where a *base model* would be used is one where the machine is located inside a building. If extended environmental conditions exist, the machine should be equipped with the additional ancillary items required to ensure proper performance.

### Moderate Environments – typically indoors:

These environments have a minimum temperature of 0° C (32° F) and a maximum of no more than 41° C (106° F) <u>as measured inside the machine</u>. Keep in mind that all electro-mechanical equipment found inside an enclosure will be affected by two sources of heat: the outside temperature of the enclosure and the heat generated by the components inside the enclosure. The MC machine series is equipped with a highly efficient "switching power supply" that generates very little heat. Therefore, the heat generated inside the cabinet is of minimal consequence. As a rule of thumb: The power supply heat will only raise the inside temperature to within 3–7° C (5-10° F) of the temperature outside the machine.

### Extended Environments – typically outdoors:

These environments are characterized by temperatures either below or above that of the moderate environment, and / or where the machine is exposed to additional weather elements. We recommend a properly equipped Rear Load model changer for these locations. Whenever possible, we highly recommend the rear load changer be placed in an area that minimizes the machine's exposure to excessive dust/dirt, direct sunlight, and/or direct rainfall. A canopy or other cover, that protects the machine from direct exposure to sunlight and the elements, is strongly recommended. This simple precaution will not only reduce maintenance issues for the changer's major operating components; it will also increase the potential operating life of the machine.

For climates that see sustained temperatures below the previously defined moderate levels ( $0^{\circ}$  C /  $32^{\circ}$  F), an optional Heater Kit is strongly recommended. For climates that see sustained temperatures above the previously defined moderate levels ( $41^{\circ}$  C /  $106^{\circ}$  F), the optional Outdoor Rated Power Supply is strongly recommended.

The Outdoor Rated Power Supply will continue to function properly when exposed to temperatures up to 60°C (140°F). Therefore, it is strongly recommended for regions in the Southern and Southwestern United States.

### 1.14 Bill Acceptor Considerations

The performance and life of the bill <u>acceptor</u> supplied with your machine is limited to the particular manufacturers' specifications. See the Bill Acceptor owners' manual for the recommended operating specifications.

<u>NOTE:</u> Most OEM bill acceptors are specified to operate properly between 0° C (32° F) and 50° C (122° F) ambient temperature. These conditions meet our recommended specifications for a moderate environment application. If the precautions, outlined above, for extended environment applications are met, we do not anticipate any adverse operating conditions associated with OEM bill acceptors.

# 1.15 Bill Dispenser Considerations

The performance and life of the bill <u>dispenser</u> supplied with your machine is limited to the particular manufacturers' specifications. Most bill dispensers will perform more reliably in environments that have low humidity and are operated between a 0° C (32° F) and 50° C (122° F) ambient temperature. A cabinet heating kit will help keep the humidity level low during daily temperature transitions (night to day when humidity can increase rapidly) and seasonal changes.

#### 2.0 INSTALLATION DETAILS

#### 2.1 Cabinet Installation Instructions

(REFER TO MANUAL: #8M00356 Modular Series Machine Installation Manual on our web site)

Standard Change-Makers manufactures change machines in the following cabinet styles: 1) Free standing consoles, 2) Front loading wall mount, 3) Through-the-wall rear load and 4) Slim-line vending changer. Because physical locations vary, we do not suggest an exact method of installation. To assure proper operation of your changer the following general guidelines should be observed:

### 2.2 Location of the Changer

The following points should be considered when locating a changer:

Service Access: Full swing of the door when opened for removing and replenishing revenues.

User Access: Easily accessed by customers and proper height from the floor. The height will vary depending upon the changer model. Accessibility for the handicapped, as required by the Americans with Disabilities Act (ADA) specifies that all controls (coin cup, coin insertion slots and bill acceptor slots) shall not be higher than 48" (1220 mm), or no less than 15" (230 mm) from the floor for Forward Reach or "Straight On" access. For Side Reach or "Side" Access, ADA requires that all controls shall not exceed 48" (1220 mm), or no less than 15" (230 mm) from the floor (revised in 2011).

The measurement shown is taken from the base (bottom) of the machine to the floor. Additionally, ADA requires a 30" (760mm) by 48" (1220mm) "clear floor space" to provide sufficient clearance for a single wheelchair and occupant.

#### **OPTIONAL HEADER INSTALLATION:**

The starter holes on top of cabinet should be pre-drilled (#35 0.1100 drill bit size) to remove the paint inside of the hole. This will ensure proper tightening of the self-tapping screw. Install header using self-tapping screws and flat washers (included) to top of cabinet. All screws should be tightened till snug, **do not over tighten.** Make sure the screws will not damage anything inside the machines.

FOR MORE INFORMATION ON THE INSTALLATION AND ADA COMPLIANCE SEE MANUAL #8M00356 – MODULAR SERIES INSTALLATION GUIDE. The ADA Compliance Chart of installation rough opening heights is available for download from our web site. (SEE: SERVICE TAB – OWNER'S MANUALS).

# 2.3 Optional Base Installation Instructions

The painted ½-20 hex. bolts must be removed and discarded from top of base. Install cabinet using new ½-20 hex bolts and flat washers (included) to top of base. All bolts should be tightened until tight.

# 2.4 Wall Mount Changers

Type of wall construction: For maximum security, it is recommended that the changer be installed on a wall made of cement block, brick or other type of masonry. A wooden stud wall is acceptable but will not provide the security or strength usually associated with masonry.

The mounting holes on the back of the changer will accommodate four 1/4-inch diameter bolts. See Section 10 for all MC changers mounting hole patterns.

#### **WARNING!**

CHANGERS MOUNTED ON BASES ARE TOP HEAVY
The changer MUST be secured to a rigid vertical surface, as well as
to the stand to provide appropriate security, stability, and safety.

If the wall to which the changer will be mounted does not meet the construction standards above, we recommend using the Standard Change-Makers stand. The stands are provided with mounting holes on the top surface for mounting the changer and holes are also provided on the bottom for securing the stand to the floor. A drill template is included with each stand. When using the stand, we recommend that the changer be bolted to the wall as well as to the stand. This provides a highly secure installation. See Section 11 for all the stand assembly diagrams.

#### WARNING!!!

Welding the cabinet to any kind of mounting <u>could cause damage to electrical components within the machine!</u> Warping of the cabinet may also occur. Welding of any kind to the cabinet during installation will void the manufacturer's warranty!

If welding is ultimately necessary, <u>all components within the machine must be removed prior to welding!</u> Please contact our Service Department with any questions.

If the changer is to be mounted to a post, the post should be sunk in concrete for stability. It is also recommended that the post be filled with concrete for strength. A steel plate with approximately the same dimensions as the changer should be welded to the post. Bolt the changer to the steel plate through the four 1/4-inch mounting holes drilled into the plate. Tack weld the heads of the mounting bolts to prevent their removal. Four nuts and washers inside the changer can then secure the changer. If this method is not feasible, the bolts can be bent after installation to prevent removal.

### 2.5 Rear Load Changers

A rear load changer cabinet must mount through a hole in the wall. The stainless steel front plate, which extends 2 inches beyond the cabinet on all sides, must be tight against the wall surface. The cabinet will be 13"-18" deep. Its protrusion into the back room will be the difference between this depth and the thickness of your wall. Allow for proper door swing. Also, lay a bead of caulking inside the front plate before installation to prevent moisture incursion.


Angle iron mounting brackets are available to secure the changer in place. One side of the angle iron should be secured to the side of the cabinet. The other side of the angle iron mounts to the wall. The installed angle irons will provide additional support needed to minimize cabinet flexing when the door is opened.



Some rear load models have the coin hoppers mounted on the door. When the hoppers are full and the door is opened, a significant load occurs on the cabinet. This load can result in cabinet flexing if the cabinet is not sufficiently supported. Repeated flexing of the cabinet can result in metal fatigue and stressed weld joints on the cabinet.

When the cabinet is installed in a cinder block wall, as shown in Figure 1, the block wall will typically provide enough support on the sides and bottom of the cabinet to prevent flexing. In locations where this type of mounting is not feasible, for example a 2x4 stud wall, <u>additional support is required</u>. To sufficiently support the cabinet, at least 75% of the cabinet bottom should be supported with load-bearing, non-flexing material such as cinderblock or iron. In addition, the sides of the cabinet must also be supported to prevent the cabinet from twisting when the door is opened. See Figure 2 for the required support areas.

Any deviation of these guidelines will void the machine's warranty.

Welding the cabinet to any kind of mounting <u>could cause damage to electrical components within the machine!</u> Warping of the cabinet may also occur. Welding of any kind to the cabinet during installation will void the manufacturer's warranty!

If welding is ultimately necessary, <u>all components within the machine must be removed prior to welding!</u> Please contact our Service Department with any questions.

# 2.6 Mounting the Changer Cabinet

If your machine was shipped with the coin dispensers in place, the dispensers should be removed before installation. If the coin dispensers have been shipped in separate carton(s), do not remove or disconnect any components.

Use four 1/4-inch diameter bolts for mounting.

#### **CAUTION**

Even the slightest uneven surface can cause cabinet distortion when mounting bolts are tightened. This can cause the doors to fit unevenly when closed. This distortion can occur even more easily on large cabinets. Should this occur, it may be necessary to shim one or more of the cabinet corners.

Make sure that the cabinet is level and the mounting surface is flat.

Be sure that the inside of the cabinet is free of metal shavings and other debris, which might have been introduced in the mounting process.

Remove all packing materials and shipping straps from the cabinet. Some items have yellow tags with removal instructions.

After installation, replace coin dispenser(s) or, if they were shipped separately, remove them from their cartons and install them. Plug in all electrical connectors.

### 2.7 Electrical Hook-Up

The changer need only be connected to a properly grounded electrical outlet (3<sup>rd</sup> wire ground back to main service panel). We also recommend that the changer be wired on a dedicated line. A dedicated line is a circuit which has no other equipment connected on the same circuit breaker or fuse. The purpose of a dedicated line is to reduce the possibility of line interference, which may cause the changer to malfunction. Some models have several cut outs allowing alternate wiring inlets. If the machine is located in a harsh electrical environment, or if dedicated line is not feasible, the use of a high quality surge suppressor (same as used for home computers) is recommended.

### **IMPORTANT**

This machine must be grounded through a properly installed 3rd wire ground, which extends intact to the main service panel.

### The Locations Electrical Supply

If this machine has a service cord that ends in a 3-pin connector. The wall receptacle you plug the machine into must be properly polarized and grounded. Operating your machine from an improperly connected power source will VOID THE WARRANTY. The wall receptacle must be able to supply a constant 120 volts at 60Hertz. The receptacle should be protected by a 15 amp circuit breaker or fuse. The machine should have its own electrical circuit. Perform checks on the power source as follows: (See photo to the right) NEUTRAL.

GROUND.

HOT

# 1. Voltage Check

When placed across the HOT and NEUTRAL terminals, a volt-ohmmeter should indicate 110-130 volts AC.

#### 2. Polarity Check

When placed across the **HOT** and **GROUND** terminals, a volt-ohmmeter should indicate 110-130 volts AC.

#### 3. Noise Potential Check

When placed across the **NEUTRAL** and **GROUND** terminals, a volt-ohmmeter should indicate no more than .5 volts AC. Readings greater than .5 volts AC indicate a poor grounding condition that could result in noise problems for the electronic circuitry.

If you are hard wiring the changer the same checks should be performed on the supply line going to the changer. Any deviation from these requirements may result in unreliable performance from your machine.

#### 3.0 LOCK OPERATION

### **T-handle Lock Operation**

The T-handle lock that the Modular Machine Series is equipped with provides quick and easy access to the interior of the changer with maximum security. To disengage the lock it is only necessary to unlock the mechanism and turn the handle counter clockwise until it disengages from the interior lock mechanism (approximately five turns), then pull the door open. The lock handle must be parallel to the floor for the lock to disengage on MC100, MC200, MC400RL, MC700 and MC900 cabinets; the lock must be perpendicular to the floor on the MC300RL and MC500RL-DA cabinet. To lock the door, turn the handle parallel to the floor then push the door closed. The lock will be automatically engaged as the door is closed. If the door is pushed all the way closed, it will only be necessary to turn the handle a couple of turns until the lock tightens. The lock handle can then be pushed into the recess of the door, securely locking the cabinet. See photos below of lock t-handle and plug locks.

### **WARNING!**

Do not place cabinet lock keys inside the changer as they may be inadvertently locked inside.

<u>SUGGESTION</u>: Place the extra key and key number tag to the changer in a safe place in the event it is needed at a later date.

#### 4.0 UNDERSTANDING MACHINE OPERATING CONCEPTS

Changes to the feature settings should only be performed if the factory settings do not provide the functionality required. It is important to understand a few basic concepts of the machine operation before attempting to alter a feature setting. Or if you choose, we have created step by step procedures in Appendix A in the back of this manual to simplify the programming sequence. You also may choose to call any of our Factory Service centers and ask for assistance. You will find our Service Center locations and phone numbers on the back page of this manual.

#### **OPERATING MODE**

In the operating mode, meaning the machine is ready to dispense coins (or cards or tickets...). the switch settings indicate the value of the dispenser. The value should be set for one ticket, token, coin or bill. See the table below for the correct switch settings for each *standard value*. Note that in row one of the table, the value is identified as "Programmed". This indicates that the dispenser value is stored in memory as opposed to being shown on the DIP switch. This setting is only used if the item being dispensed is not the equivalent of a standard coin value. Read the following sections for more information about the DIP switches. The most common Value of coin dispenser is a quarter. This would be found in row 5 of the table and it looks like this:

#### **VERY IMPORTANT:**

SW2-SW5 should always be set to reflect the correct dispenser value, and SW1 should always be in the *DOWN* position, when the dispenser is in the *Operating Mode*.

#### MAKE BEST CHANGE FEATURE

This allows your machine to operate in a manner that is easy to understand and results in the least amount of programming. Your machine will *automatically* figure out the *best change combination* for each deposited amount, based on the value of the dispenser(s). The *best change combination* is the one that results in the least number of coins dispensed from the machine.

The *make best change* feature is modeled after an actual employee making change. You would expect them to *automatically* know how many quarters to give out for a \$1 bill, how many for a \$20 bill, and so on. Your MC series machine will automatically figure this out as well so you no longer have to be concerned with the specific dispense programming necessary to accomplish such a basic function of a change machine.

Additional automatic functionality is also included that will further enhance the owner friendliness of this machine. For example, if two of the same type coin dispensers are available (example: 2 quarter hoppers), the machine will *automatically* figure out that it should give even amounts out of each dispenser for each deposit. In addition, if one of the coin dispensers can no longer function properly, the remaining dispenser will take over and complete the transactions.

The *Make Best Change Feature* is always active. When used in combination with the Forced Vend Feature you can configure virtually any dispense combination desired. See the "Feature Settings" section of this manual for an explanation of the Forced Vend Feature.

#### **DEVICE & MACHINE FEATURE DIFFERENCES**

DEVICE FEATURES - Each device (dispenser) is capable of managing its own features and related functions. These features will be referred to as "DEVICE FEATURES".

MACHINE FEATURES - In addition to managing its own Device Features, each device (dispenser) can also manage machine features. Machine Features and related functions, are those that have to do with the overall **machine**, whereby Device Features only relate to a specific **device** (module). Examples of Machine Features are: Fast Vend Shutoff, Bill Acceptance and Security, and Automatic Reset. Machine Features are managed by a designated device. This device is called the Primary Device.

#### PRIMARY DEVICE

Machine Features are managed by only one device in the machine. The device that manages these is referred to as the "PRIMARY DEVICE". The location where the primary device is mounted within the machine is identified with a label marked "Primary Device". All other devices are considered SECONDARY DEVICES and their locations in the machine are not labeled.

#### VERY IMPORTANT NOTE REGARDING PRIMARY DEVICE LOCATION:

The factory programming of the "Machine Features" is identical in all devices. This allows ease of replacement should a new or replacement device be placed in the Primary Device location. Any device can be used as the Primary Device. However, the new device should contain the correct programming for the desired Machine Features. Therefore, if an alteration has been made to the factory settings of the device that is removed, the replacement device should also contain the desired Machine Feature programming. Be sure to program the desired Machine Features into the new module before placing the machine back into service.

### 4.1 Dual Redundancy Operating Mode

Models that include two bill acceptors and at least two dispensers can be configured to operate in one of two modes. Each mode offers a unique set of benefits. The mode selected will be dependent upon the benefits that best suit your operation. Either mode can be utilized by making simple cable changes. See the connection diagrams below for setting up each operating mode.


Single coin cup machine models are shipped with the *Dual Redundancy* mode activated. This mode allows the two bill acceptors to operate effectively as one, thereby increasing the overall machine reliability. In the event one bill acceptor should become disabled, the remaining acceptor will continue to accept currency and utilize all available dispensers to make change.

Machines with two separate coin cups are factory-configured to operate in the *Independent* mode. There is a possibility for user confusion that results from using the *dual redundancy*-operating mode in a cabinet that has two coin cups. In this mode, all coins dispensed as a result of a bill deposited in **either** bill acceptor, will end up in only **one** of the two coin cups; the coins are not always dispensed into the coin cup on the side of the machine that the bill was deposited into.

**Electrical Connection For Dual Redundancy Mode Operation:** With the machine power off, connect a control cable (4C00316-short cable or 4C00299-long cable) between two coin dispensers. The cable ends are color coded to correspond with the color code dot on the dispenser logic board. If the machine was shipped to you in the *Independent* Operating Mode, this cable was supplied in a small plastic bag. In a two-dispenser machine, connect the blue end of the cable to the "Primary" dispenser connector. In a three of four-dispenser machine, connect the cable between the two dispensers that do not already have a data cable connected between them. Route the cables in a way that they will not be pinched by the coin dispensers when a dump is performed.

Electrical Connection For Independent Mode Operation: With the machine power off, remove one of the control cables (4C00316-short cable or 4C00299-long cable) that is currently connected between two dispensers. Be sure to keep this cable to allow you to convert back to the Dual Redundancy Mode at a later date if desired. In a two-dispenser machine, remove the cable that is connected between the two dispensers. In a three of four-dispenser machine, remove the cable that is connected between the second dispenser (from the left side) and the third dispenser.





#### 5.0 MACHINE AND DEVICE FEATURES

Below is the list of features provided by the MC changers, followed with a brief description of their functions. The factory uses the default settings as listed unless a change in the setting was specified by our customer. If you choose to change any of the feature settings, please refer to Appendix "A" in the back of this manual for the step by step procedures. Or if you choose, you may call any of our Factory Service centers and ask for assistance. You will find our Service Center locations and phone numbers on the back page of this manual.

### 5.1 Bill Acceptance and Bill Security (Feature Type = Device)

• Default Settings for all bills: Security=High / Accept =Yes

The validation security for each bill denomination can be set HIGH or LOW depending on your security and acceptance requirements. Higher security requires greater authentication scrutiny and as a result will result in a lower acceptance rate of genuine bills. In addition, bill acceptance can be set to yes or no for each denomination. As an example, if you decide not to accept twenty dollar bills, you would select Security = High and Accept = No.

### **5.2** Fast Vend Shutoff (Feature Type = Machine)

• Factory Default Settings

Time Period = 15 minutes for all bill denominations.

Max Qty of each bill supported (based on country) is:

- U.S. currency: \$1 = 45, \$2 = 45, \$5 = 20, \$10 = 10, \$20 = 5, \$50 = 2, \$100 = 2.
- Canadian currency: \$5 = 20, \$10 = 10, \$20 = 5, \$50 = 2, \$100 = 2.
- Mexican currency: 20 peso = 20, 50 peso = 10, 100 peso = 5, 200 peso = 2, 500 peso = 2.

The Fast Vend Shutoff feature can be used to limit the loss of revenue in the event a thief has devised a method to successfully remove a bill after the vend has been initiated, and the bill acceptor cannot detect and report the presence of a string or other manipulation device.

This feature works by allowing the machine owner to establish a normal usage pattern for their individual site or environment. The usage pattern is based on a normal *quantity* of each bill denomination being deposited in a certain *Time period*. In other words, if a large *quantity* of \$20 bills is deposited in a short *Time Period*, the machine can be set to identify this unusual pattern and shut itself off for a given time frame thereby preventing further revenue loss.

### **5.3** Error Timeout (Feature Type = Machine and Device)

### • <u>Default Settings = 15 minutes</u>

This feature allows the machine to automatically reset from certain error types; at this time the Error Timeout only applies to Fast Vend Shutoff, a Stringing Detected Error and Overpay error conditions. For these errors the machine will be automatically reset following a predetermined time period.

Notes: The 0 minutes setting (row 1) disables the error timeout. If power is cycled while the machine is in this condition, the Error Timeout (minutes setting) will be reset and the time out count down will start over.

### **5.4** Serial Control (Feature Type = Machine)

### • <u>Default Settings</u> = None

This allows the use of the Standard Change Makers serial protocol for authorized projects. The use of this should have been negotiated with Standard Change Makers. Accepted bills and coins will be reported to the computer. The computer will decide the payout, if any, of the dispenser.

None – A computer will not be communicating to the dispenser. This is the default dispenser mode

**Control** – A computer will control the dispensers using the Standard Change Maker protocol. Communication every 20 seconds is required from the computer or the machine will go offline. This is done so bills and coins will not be stolen because the computer is not available.

**Control Relaxed** - A computer will control the dispensers using the Standard Change Maker protocol. Communication every 20 seconds is not enforced.

# **5.5** Power Reset (Feature Type = Device)

• Default Settings = Disabled

The Power Reset will allow all errors to be cleared upon a power cycle.

# **5.6** Hold Escrow (Feature Type = Machine)

### • <u>Default Settings = NO</u>

During a coin accumulation through the coin acceptor (Example: 2 dimes + 1 nickel = quarter payout) a customer may deposit three dimes and receive one quarter. If a five-cent hopper is not available in the machine, an escrow (unpaid balance) of 5 cents is present. This feature allows you to clear this escrow amount or simply "Hold" it and add the amount to the next deposit. To hold the escrow amount set this feature to YES.

### 5.7 Dispenser Transfer (Feature Type = Machine)

### • Default Settings = Transfer Less

The term TRANSFER refers to the machines' capability to "transfer" an owed amount from a dispenser that is in error or soldout. There are three different transfer operating modes available with your machine. **Transfer None** – No transfer. If any of the available dispensers fail or becomes soldout, the machine will be placed out of service. The machine will only go out of service after the dispense in progress is transferred to any available dispensers. This will allow the last patron to receive their full amount due. This final vend amount will be in the form of "make best change" (least number of coins).

**Transfer Equal** – Transfer will only occur if another dispenser of the same type and value as the failed dispenser is present. Example: If two quarter (value) coin dispenser (type) are present and one fails, all remaining and future vends will be issued from the remaining coin hopper until the failed hopper is returned to the operating condition.

**Transfer Less** - The machine will stay in service as long as one of lowest valued dispensers is available. Transfer will occur to the same type of equal or lower valued dispensers. Example: Two quarter coin dispensers and a nickel coin dispenser are present and a quarter dispenser fails. All remaining vends will be issued from the other quarter coin dispenser until the failed hopper is returned to the operating condition. If at any time the nickel coin dispenser should fail the machine will go out of service.

### **5.8** Forced Dispense Feature (Feature Type = Machine)

### • Default Settings = 0

This feature allows you to force a dispense amount (quantity) from the Primary Device. The Make Best Change function will manage the remaining dispense amount should there be any value remaining in the machine. This can be useful if you want to force a lower denomination coin to be dispensed even if a larger denomination dispenser is available. Remember – the Make Best Change will try to dispense from the larger dispenser first.

The first step (7) will set the ten's digit (of the two-digit number), the second step (8) will be used to set the second digit. The Forced Dispense amount can be from 0 to 99. Use the parameter table below to set the TENS DIGIT as well as the ONES DIGIT for this feature.

Example: A nickel coin dispenser and a quarter coin dispenser are present. You would like to *force* at least 5 nickels to be dispensed for every bill deposited. In the MBCM, the vend would consist of only quarters. To change this, you would set the nickel dispenser to be the *Primary* device and set the *Forced Dispense* to 5. The dispense would then consist of the Forced Dispense amount or 5 nickels, and the rest would be issued in quarters. Note – the forced dispense only forces from the *Primary* device.

### **5.9** Forced Dispense Override (Feature Type = Machine)

### • <u>Default Settings = OFF</u>

This feature allows the machine to ignore the *Forced Dispense Feature* setting under special deposit circumstances. The special circumstance occurs when the deposit is Equal To an available dispenser. If the value of the amount deposited matches a dispenser value, a dispense is issued from that dispenser. In this way the dispenser value overrides (ignores) the Forced Dispense Feature setting. Note: this feature is rarely implemented as it typically not necessary to accommodate the desired vend responses.

Example: Feature Settings are set to: Primary Device (Dispenser)= \$.05 (nickel hopper), Secondary Device (Dispenser) = \$1.00 (\$1-coin hopper or bill dispenser), and Forced Dispense Feature setting = 20.

\$1 accepted: Payout is 0 from the Primary Device and 1 from the Secondary Device.

Note: The forced Dispense Feature would normally force 20 nickels to be dispensed.

\$5 accepted: Payout is 20 from the Primary Device and 4 from the Secondary Device.

### **5.10** Accumulate (Feature Type = Machine)

• Default Settings = Disabled

When this feature is enabled, a dispense will not occur until enough money has been accepted to meet or exceed the value of the PRIMARY DEVICE. Make Best Change will then occur.

# **5.11 Dispenser Type (Feature Type = Device)**

• <u>Default Settings = Coin</u>

This feature is only necessary if you wish to convert a dispenser from one type (say a regular coin – quarter) to a token type (say a .984 token). Changing this feature can greatly alter how your machine works. Valid dispenser types are: Coin, token, bill, ticket and card.

# **5.12 Dispenser Sub Type (Feature Type = Device)**

• <u>Default Settings = Uninote Dispenser</u>

Dispenser type must be set to Bill Dispenser <u>before</u> setting the Dispenser Sub Type. The Dispenser Sub Type allows the owner to select which Bill Dispenser model is being used in the machine. This will establish the correct communication and machine options for the selected Bill Dispenser.

### **5.13** Stringing Detection Level (Feature Type = Machine)

• <u>Default Settings = Medium</u>

LOW – Only validator detection will be used. If the validator detects a possible stringing attempt it will not issue credits. The System Controller will ignore all MDB codes that may indicate a possible stringing attempt.

**MEDIUM** – The Device will ignore MDB codes that may indicate possible a stringing attempt only when there are no credits. If there are credits or a payout is in progress, the changer will shut down with a bill acceptor error. No further transactions will occur until the machine is reset either manually or with the Auto Reset feature.

**HIGH** – The Device will go offline if any MDB codes that may indicate a possible stringing are received. The changer will shut down with a bill acceptor error. No further transactions will occur until the machine is reset either manually or with the Auto Reset feature. <u>False errors may occur if bills are rapidly fed into</u> the machine.

### **5.14 Count Out Items (Feature Type = Device)**

• <u>Default Settings = Dollars</u>

This feature is only necessary if you wish to count the number of items dispensed rather than the dollar amount dispensed.

### **5.15** No Bill Acceptor Shutdown (Feature Type = Machine)

• <u>Default Settings = NO</u> Available in software version 01.037 or newer

This setting can be used to force the machine offline (out of service) if the bill acceptor is no longer available to accept bills as a result of an error condition. The default setting will keep the machine online if another type of acceptor is available; for example, a coin acceptor is present.

# **5.16** No Coin Acceptor Shutdown (Feature Type = Machine)

• <u>Default Settings = NO</u> Available in software version 01.037 or newer

This setting can be used to force the machine offline (out of service) if the coin acceptor is no longer available to accept coins as a result of an error condition. The default setting will keep the machine online if another type of acceptor is available; for example, a bill acceptor is present.

### **5.17** Like Value Override (Feature Type = Machine)

• Default Settings = NO Available in software version 01.037 or newer

This feature is used primarily in BX machine models that are not equipped with an EF Module <u>and</u> do not use the *Forced Dispense Override* feature. Without the *Forced Dispense Override* the same denomination bill can be paid out as the one that was deposited. Example: \$5 bill deposited = \$5 bill dispensed. Without a Forced Dispense, the Make Best Change feature will determine that the best payout (least number of bills needed) would be a \$5 bill. Since this is undesirable, the *Like Value Override* can be set to tell the machine to use the lower denomination dispenser instead of the Like Vale (same as the deposited amount). When set to YES a \$5 input would pay five items from the \$1 dispenser.

### **5.18 Mylar Note Check (Feature Type = Dispenser)**

• Default Settings = NO Available in software version 03.085 or newer

This feature is used on boards that are controlling a Fujitsu bill dispenser that is dispensing plastic (mylar) bills.

### **5.19 Overpay Timer (Feature Type = Machine)**

• <u>Default Settings = NO</u> Available in software version 03.097 or newer

This feature is used to automatically clear an overpay error. Be careful using this in that it can hide a serious problem. This uses the Error Timeout of the primary dispenser or EF+ if you have one.

# **5.20** Bonus Tokens (Feature Type = Machine)

• Default Settings = 0

Bonus tokens (cards, tickets...) are those that are issued at no cost. In other words, they are given away as a bonus to the machine user. These are the same tokens given out during the normal machine dispense, and yet they have no value. A common use of the bonus token feature is to give out extra (bonus) tokens with larger token purchases.

The Bonus Token for each bill can be from 0 to 99. It is necessary to enter two digits for each bill denomination. The tens digit for a denomination will be entered first, and in the following step the ones digit will be entered. The parameter table below is used for both steps.

Note: The *Primary Device* type must be set to TOKEN for the Bonus Token settings to be used.

Bonus Token Example: For a \$20 bill deposit you wish to give out 4 bonus (extra) tokens. The value of the token dispenser was set to 25 cents. The *Make Best Change Feature* will automatically give out 80 tokens. The *Bonus Feature* will then add the additional 4 bonus tokens to the total tokens to be issued for the \$20 deposit. The machine user will receive 84 tokens.

### **5.21** Dispenser Value (Feature Type = Device)

### • Default Settings = \$00.0

This feature allows you to set a dispenser value other than those listed in the DISPENSER VALUE SETTINGS table shown in the Operating Mode section of this manual. This allows you to set the value to anything between \$0.05 and \$99.95, in nickel increments. This would typically be used for ticket, token or card dispensers. Some machines are equipped with a multi-cassette bill dispenser. The value of each cassette is setup using this feature. The value is for one item.

The method used is one whereby you set the four digits (of the value) starting with the tens digit of the dollar amount. For this value to be used, all the switches (SW1-SW5) must be in the DOWN position when you exit the *Configuration Mode*. This is the only case where you would not return the dip switches to the operating mode settings. If any of the switches are up, the DISPENSER VALUE SETTINGS will override the value you have set in these steps; the value is still there, however, it will just not be used.

Multi-Cassette Bill Dispensers- If the machine is equipped with a multi-compartment bill dispenser (Fujitsu F53), the value of each cassette will need to be setup. Note - Any cassette that does not have a value programmed will not be used for the dispense cycle and will not appear in the Configuration Report on an Extended Function module. Steps 1-4 are used for the top cassette, steps 5-8 are used for the next one down, steps 9-12 are used for cassette the next one down, steps 13-16 are used for the next one down, etc.

Example for setting the value of a \$5.00 bill cassette located in the top position of the dispenser:

Steps 1 – Enter the tens digit for the dollar amount	\$0
Steps 2 – Enter the ones digit for the dollar amount	\$_5
Steps 3 – Enter the tens digit for the cents amount	\$0
Steps 4 – Enter the ones digit for the cents amount	\$0

Setting the value for Step 4 is different than steps 1-3 in that you can only set it in nickel amounts. This means that the last digit can either be a zero or a five. As an example you cannot have a dispenser value of \$12.77. It has to be either \$12.75 or \$12.80.

# **5.22** Ticket Coast Time (Feature Type = Device)

### • <u>Default Settings = 50 msec</u>

This is the amount of time the ticket device will remain on even after the last ticket notch is detected. This is useful if you would like to leave a little extra ticket sticking out the front of the machine. Caution should be taken to avoid excessive coasting as ticket tearing can occur.

### **5.23** Ticket Transfer Factor (Feature Type = Device)

• <u>Default Settings = 2</u>

This setting is only used if you have set the ticket dispenser to "transfer" (see Dispenser Transfer) ticket dispenses in the event the ticket dispenser becomes empty. It is necessary as a result of a physical limitation in the ticket issuing device and therefore is represented as a "Factor". If you do not intend to transfer from the ticket dispenser, you do not need to change this setting for any reason.

To determine the TTF (Ticket Transfer Factor) needed, use the following formula: TTF = 4.0"/length of a single ticket. For a standard 2.0" ticket the TTF = 2 which is the default setting (2 = 4.0" / 2.0"). It is important to note that the ticket transfer factor must equal to the whole numbers 1,2 or 4 for the transfer to work properly. Any other TTF will not allow the ticket dispenser to transfer properly

### **5.24** Tickets Per Notch (Feature Type = Device)

• Default Settings = 1 Available in software version 01.034 or newer

Each notch between tickets will be counted as one ticket. This feature is used if more than one ticket is dispensed yet only counted (notch) as one. Settings other than the default are used in applications where two side-by-side tickets are dispensed while the ticket issuing device only counts (notch) one ticket. This unique circumstance typically occurs when two 1" ticket rolls (or fan fold) are manufactured side-by-side and dispensed from ticket issuing device capable of dispensing 2" wide tickets.

### **5.25** Bin Low Count Value (Feature Type = Device)

• <u>Default Settings = 30</u> Available in software version 01.037 or newer

This feature is typically used to decrease the number of bills remaining in a bill dispenser compartment (cassette) before it reports that it is sold out. Use this to allow between 0 and 255 additional bills to be dispensed after the bill compartment senses it is sold out. The number of bill remaining after the bill compartment senses a sold out will vary depending on the condition of the currency being used. Do not set this number too high as it will allow the dispenser to run completely empty which could result in a short pay to the machine user if the machine cannot transfer the unpaid balance to another dispenser.

The method used is one whereby you set the three digits (of the value) starting with the hundreds digit of the value.

An example of 30 will be used.

**Steps 1** – Enter the Hundreds digit for the amount. 0--

Steps 2 – Enter the Tens digit for the amount. -3-

Steps 3 – Enter the Ones digit for the amount. –0

# **5.26** Bin Low Override (Feature Type = Device)

• <u>Default Settings = OFF</u> Available in software version 01.037 or newer

This feature can be used to maximize the dispense capacity of a multi-bin (multi-cassette) bill dispenser that has two or more cassettes loaded with the same denomination of bill. Setting the "override" to on for a cassette will disable the sold out detector and allow the 40-70 bills that typically remain, to be dispensed. This feature will allow one cassette to dispense every bill before the next cassette with the same bill denomination, is activated.


Steps 4 – Enter override for cassette 1
Steps 5 – Enter override for cassette 2
Steps 6 – Enter override for cassette 3
Steps 7 – Enter override for cassette 4


### 6.0 TROUBLESHOOTING & MAINTENANCE

### 6.1 Dispenser Flash Codes

When an error occurs the dispenser will display a flash code with the yellow status LED to indicate the particular error. If a two-digit flash code is present, a *short pause* will occur between the *first digit* and the *second digit* of the flash code. Following are examples:

#### **EXAMPLE OF A FLASH CODE ERROR 9**





### **6.2** Troubleshooting Chart

The purpose of this chart is to assist you in troubleshooting failures that may occur during normal usage, and that do not require factory repair. *Example: a bent coin or a coin bag string that is stuck in the coin dispenser mechanism.* If you cannot resolve the issue in the field, contact your nearest service center or send the faulty module in for repair. Be sure to include a note that indicates the flash code error that was displayed as well as a detailed description of the circumstances (clues) surrounding the failure. These clues will assist the technician in quickly and accurately diagnosing the fault. This will ultimately reduce the cost of the repair.

#### General Troubleshooting Hints:

- Always check the connection, plugs, etc. for the device that has issued the error code.
- Check the associated cable (s) and connections. Look for loose plugs, broken wires or frayed wires where the wire meets the connector.
- Check associated cables for pinched or broken wires.
- Always press the *push button* on the device after you have performed the repair and reapplied power.

Flash Code	TROUBLESHOOTING HELP & COMMON FAILURE SOURCES
1	THE DISPENSER IS <b>SOLD OUT</b> . This is a normal operating condition and it indicates that the dispense compartment needs to be refilled. Once refilled the error condition will automatically go away (reset). If this error is issued and the device is not sold out (near empty), check the device sold out sensing contacts / circuit for debris. When the dispenser is sold out the OOS light will flash slowly.
2	<ul> <li>A BILL ACCEPTOR ERROR WAS DETECTED. The bill acceptor has detected an error. Check the items listed below. If this does help identify the problem source, note the flash code displayed on the bill acceptor and refer to the bill acceptor owners' manual for additional troubleshooting assistance.</li> <li>Ensure the bill acceptor cable is plugged in properly.</li> <li>Check the data cable (gray phone style cable labeled 4C00299) to ensure it is plugged in properly. The cable is color coded at each end. Be sure the blue cable end is connected to the blue connector on the circuit board.</li> </ul>
3	THE <b>BILL STACKER</b> IS <b>MISSING</b> OR <b>FULL</b> – Empty the Bill Stacker and press the reset button on the Primary Device. If the problem persists, remove the bill stacker and look for dirt or debris in the acceptors bill path. Reinstall the bill stacker, making sure it latches securely in place.
4	A <b>BILL JAMMED</b> ERROR – The bill acceptor has detected a stuck bill or foreign object in the note path (path bill travels through the Note Acceptor). Remove the item from the note path. Note: If this problem persists, check the note path drive roller system for excessive wear (missing, cracked or stretched) on the belts or O-rings. Clean or replace as necessary.
5	A <b>FAST VEND</b> SHUT-OFF ERROR – An abnormal sequence (quantity in certain time period) of bills was deposited and the machine was automatically disabled. See section of this manual that discusses the Fast Vend Shut-off setting, for more details regarding this feature.
6	<b>STRINGING</b> WAS DETECTED – The stringing detection software has determined that a bill has been pulled out or attempted to be pulled out. Look for string, tape or debris. Balance (reconcile) your machine revenue.
7	A COIN ACCEPTOR ERROR WAS DETECTED. Check to ensure that a bent coin or piece of debris is not interfering with the coin deposit path. Check the associated cable (s) and connections.
8	<ul> <li>A DISPENSER ERROR WAS DETECTED.</li> <li>If the Sold-Out contacts for the dispenser have been bypassed, this error will occur when the dispenser becomes completely empty. Press reset after refilling the dispenser.</li> </ul>

	• Check for debris in the dispense path of the associated dispenser - If blocked or dirty, remove debris. Check the counting optics (device eyes) and remove excessive dust or debris. Check the associated cable (s) and connections. Check the dispensing mechanism for debris - bent coin, coin bag string, stuck bill
9	A FATAL <b>MEMORY</b> ERROR WAS DETECTED – Warning: the memory device that stores all critical setup information (dispense amounts, security settings) is failing. DO NOT reset the associated device or place it back into operation!!! Replace the device logic board or send it in for repair with a note stating the following – "The EE memory has failed and will need to be replaced".
10	<b>POWER</b> FAULT DETECTED – Power was lost during a dispense. Check for intermittent connections or a faulty power line condition, i.e. loose plug, corroded connections, or too much load on one circuit. Warning: Power faults can result in short pays.
11	AN <b>UNKNOWN</b> OR UNDOCUMENTED ERROR WAS DETECTED – Contact a service center for an updated error code list, and/or reset the machine and check for proper performance before placing back into service.
12	<b>ILLOGICAL</b> – An illogical setup was detected. Examples – All bill acceptance is turned off, the dispenser type is invalid, the dispenser was told to dispense more than 200 coins, tokens, bills or tickets.
13	<b>DATA</b> BAD ERROR – The machine has lost a portion of temporary memory. This error is not fatal and the machine will remain on-line. If a vend was in progress when the error was detected, the vend amount and associated count were cleared. This error is typically caused by excessive power surges. Install a surge filter on the power line to the machine.
14	<b>OVERPAY</b> LOGIC ERR – The device calculated it was told to dispense to many items. Check Dispense limit settings for the affected device. Check the Program settings.
15-	TRACKING CODES – These codes are intended for use by SCM troubleshooting personnel. If code
30	persists, contact the nearest SCM service center.
31	DISPENSER <b>OUTPUT</b> BLOCKED – The dispenser (coin, bill, ticket) sensor is blocked. Check the dispenser counting sensor and associated connections.
32	DISPENSER IS <b>EMPTY</b> – The dispenser (coin, bill, ticket) is empty. If dispenser is not empty, check the sold out sensor connections.
33	DISPENSER IS <b>JAMMED</b> – The dispenser (coin, bill, ticket) is jammed. Check the dispense path.
34	DISPENSER HAS A <b>SENSOR</b> ERROR – <b>Something has passed the sensor when it was not expected.</b> Check for debris mixed in with the coins or bills. Debris can be counted as an extra "item". The board or dispenser chute may be loose causing the dispenser to see something. If the error is from a ticket dispenser, check the tickets for tears in the area around the ticket notch. Extra notches (tears) can be counted as a ticket.
35	BILL DISPENSER <b>COMMUNICATION</b> ERROR – The bill dispenser is not talking. Check the communication (data) cable connections. Make sure the dispenser has power to it as well.
36	Not Used – Contact factory if error persists after resetting.
37	Not Used – Contact factory if error persists after resetting.
38	Not Used – Contact factory if error persists after resetting.
39	BILL DISPENSER CARTRIDGE IN WRONG POSITION – One of the bill cartridges in a multi-note dispenser is in the wrong position. Check position of all bill cartridges.
40	Not used
41	Auto Address attempted during a dispense.

#### **6.3** Frequently Asked Questions

An owner can typically resolve many problems after he/she has been familiarized with our machine. The following are a few examples of questions and answers you may have concerning our equipment.

- My out of service light is blinking and the machine won't take a bill! A flashing OOS light indicates a hopper sold out condition. Add enough coin/tokens to cover the black funnel inside the hopper.
- My bill acceptor is rejecting too many bills! Dirty sensors can cause bill rejection. Open up the bill path and clean the sensors and rollers. Also, check with the bill acceptor manual for error code and troubleshooting information. Worn bills can also cause rejections.
- How do I turn on or off the acceptance of certain bills? Refer to the following sections of this manual: "Understanding The Configuration Mode Process" and "Bill Acceptance and Security".
- My Out-Of-Service light is on solid and the machine won't take a bill! Refer to the troubleshooting section of this manual for help on isolating the problem source.
- My acceptor takes the money, but the hopper won't dispense change! Check the dispenser labeled "PRIMARY DEVICE" for a flash code and use it to isolate the source. Also, check all connections. Dump the hopper and press the "hopper dump" button and verify that the feed mechanism is rotating. If not remove any debris that is jamming the mechanism.
- <u>I need to send you a part for repair</u>. <u>Do I need a RMA number?</u> (Return material authorization number). No, we only ask that you include your name, phone number, address and a brief description of the failure. We will process and return your product ASAP.
- I need to upgrade the software in the controller. Can I do this myself?

  Software revisions for the Simple Function Modular Machines are not common. But as new features are added you may decide to upgrade your changer. Contact your nearest service center for information regarding our board exchange program. A board containing the software can be easily exchanged.

#### 6.4 Maintenance

**Removing a Module for Repair -** All modules have been packaged in a manner that will allow the easiest possible removal and require the least number of tools possible. The following tools are recommended:

- 7/16, 3/8 and 11/32 sockets or nut drivers; used for  $\frac{1}{4}$ -20,  $\frac{10}{32}$  and  $\frac{18}{32}$  nuts.
- Socket extension; used for long reach in deep cabinets.
- Flat head, #2 Phillips and #0 Phillips screw drivers; used for removing module covers.
- Needle nose pliers and wire cutters; used for removing small parts and cable ties.

#### Bill Acceptor

- Use canned air regularly to remove dust and debris from bill path.
- Use clean damp rag to wipe off optic sensors on the upper and lower track assemblies.
- Review OEM manufacturer's information for additional tips.

#### Coin/Token Hopper

- Dump hopper once every six months and remove bent coins or tokens.
- Use canned air to remove dust and debris from hopper shell and dispenser area.
- Use a clean Q-tip and wipe off the coin interrupters located on either side of the coin chute openings.


#### **Bill Dispenser Cleaning**

• Fujitsu F50 and F53 Bill Dispensers - The owner's manual for these dispensers will identify the maintenance items associated with each specific model. If you did not receive the manual, please contact the nearest Standard Change-Makers service center for a replacement manual. The Fujitsu F50 manual is 8M00503 and the F53 manual is 8M00504.

#### **Updating the Dispenser Software**

- 1. Insert the micro SD card with the firmware update (firmware.bin). The connector is a push-push. Push to insert and push to release the card.
- 2. Press the red reset button.
- 3. The red LED should come on solid and the yellow LED will flash quickly when the memory is being erased.
- 4. The red LED blinks quickly while the yellow LED is off when the memory is being programmed.
- 5. When the yellow light stops flashing quickly you can remove the card.

#### **Dispenser Details**

#### 6.5 Optional Coin Dispenser Counter

The Optional Coin Dispenser Counter will show a count of the number of items (coins, tickets, bills...) that were dispensed. The counter is an electromechanical type.

#### 6.6 Coin Dispenser Sold-Out Configurations

Factory default settings: \$20 sold-out level

The sold-out level (level of coins remaining in the coin dispenser) for the dispenser should be set to prevent a short pay condition that can occur when the coin reserve is near empty and a patron inserts a large denomination bill. In other words, you will want to leave enough coins in the dispenser to ensure that the last person to use the machine before it shuts off due to an empty condition, receives all of their change. Therefore, the sold-out level setting should match or exceed the value of the largest bill denomination to be accepted, typically a \$20 bill.

To determine how to set the optimum sold out level see the pictures below. To access the sold-out level settings, simply open the dispenser door. You may need to remove the shipping screw prior to opening the door.

Note: If the Dispenser becomes empty in this configuration, a Dispense Error will occur. The Reset Button on the dispenser must be pressed

#### 7.0 BILL DISPENSER

#### Fujitsu Bill Dispenser

#### **Bill Dispenser Cassette Magnets**


The magnets only indicate the position of the cassette not the denomination. If you want to change the denomination see setting the Dispenser Value. The cassettes are keyed to match a particular location in the multi-note bill dispenser. This keying process ensures that the correct cassette is installed in the corresponding bill dispenser location. If a cassette is installed in the wrong location a flash code "39" will appear on the bill dispenser control module and the bill dispenser will not enable.

The following procedures explain how to set the keys (Magnets) in the cassettes should it become necessary at any time. Example: if a replacement cassette is required or if an additional dispense cartridge is added to upgrade from a dual cassette dispenser to make it a triple cassette dispenser.

#### 7.1.2 How To Set Cartridge Position Magnets


Use the procedure below to set the "cartridge position" magnets. These magnets are used to make sure the cassettes are not inadvertently placed into the wrong location in the dispenser. A flash code "39" on the bill dispenser controller module (silver box w/red reset button – see picture on following page) indicates that the wrong cassette (or cassette w/wrong magnet pattern) was installed in the dispenser.






IMPORTANT NOTE: The magnets are polar sensitive. The face of magnet is painted white. Be sure byed the magnet to a new spot.
















#### 7.1.3 Setting The Magnets for The Correct Cassette Locations

Locate cassettes as shown. Each cassette has a magnet that is used to identify and verify that the correct cassette is installed in the correct location. The top cassette should always be set to "A", the second to "B", the third to "C" and the fourth to "D" if needed.



#### 7.1.4 Setting the cassette bill denomination

The denomination (\$1, \$5, \$10 or \$20) of each cassette is stored in the memory of the bill dispenser controller module (see picture to the right). The denomination of each cassette will need to be programmed into this memory using the DSS switch setting procedure outlined in the "Dispenser Value" section of this manual.



#### 8.0 PART ORDERING INFORMATION

To obtain service on a component or module, please follow these instructions.

- 1. Locate the fault to a specific component or module. See the troubleshooting section of this manual for assistance.
- 2. Call your nearest Standard Change-Makers service center. You will need to give the service representative the following.

- 3. If you cannot furnish these numbers, it will be extremely difficult for the service department to help you. The serial number and model number are located on a label inside your machine. Service center phone numbers are given on the last page of this manual.
- 4. Always remove power from your machine prior to removal of a component.
- 5. Remove the faulty component from the changer cabinet.
- 6. If the component is to be returned to the factory or service center, pack the component in the original factory packaging if possible. If the original packaging is not available, use a suitable substitute. Care should be taken to prevent damage to the components from electrostatic discharge and mechanical shipping damage.

**NOTE:** Please avoid the use of Styrofoam "peanuts" when packing. If peanuts are used, the component should be encased in a plastic bag to prevent clogging the mechanism.

#### 10.0 HOW TO CHANGE A FEATURE SETTING

Appendix "A" which follows this section, simplifies the process of changing a feature if you so desire. The step by step procedures allows you to insert your "choice" or "choices" for the feature(s) you want to change. The photo below illustrates the components that are used for programming, followed with a description of their use.



**Step Indicator** - The yellow or top LED is the *Step indicator*. During the programming sequence, this LED flashes a code indicating which *Step* you are on or when flashing in unison with the red LED indicating which group you are in.

**Choice Indicator** - The red or bottom LED is the *Choice indicator*. During the programming sequence, this LED flashes a code that can be used to lookup the current choice for a given feature, or when flashing in unison with the yellow LED, will indicate which group you are in.

**Push Button** – The push button is used to enter a new setting (shown on the DIP switch) into the dispenser memory. This same button is also used to advance to the next *Step*.

**DIP Switches** –The dispenser includes a 5 position switch (see picture above) that is located on the dispenser circuit board which is used during the programming sequence. It is very important, be sure to return all five switches back to the original (*Operating Mode*) settings upon completion of the programming process.

#### **RESTORING THE FACTORY SETTINGS**

If at any time you wish to set all of the *Feature Choices* back to the factory setting, you can do so by setting SW1-SW5 to the UP position, and pressing the push button one time. The Status/Step LED will flash a one. This will set all features back to the factory default settings.

Note: The five-position switch and red selection button are located on the dispenser control board of the device marked "Primary". For machines with multiple bill acceptors, these settings must be set on the dispenser control board that each bill acceptor is plugged in to.

IMPORTANT: Please note the original switch settings before starting this procedure. You will need to return the switches to this original setting to assure proper operation after making any changes. As a convenience, you can enter these original settings in the diagram to the right by simply marking an "X" for UP or DOWN on each switch.

- 1. Activate the Bill Acceptance and/or Bill Acceptance Security Level mode by setting: Switch 1–ON; Switch 2-OFF; Switch 3-OFF; Switch 4-OFF; Switch 5-ON
- 2. Press the red selection button one time. This advances you to the 1<sup>st</sup> Step as per the Chart below. This Step is for a U.S. \$1, a Canadian \$5, or a Mexican \$20 note.

This setting only needs to be made in the primary dispenser or the EF+ if you have one.


